If the Company is delayed by any circumstance or event beyond its control then it may suspend or extend the delivery time for the whole or any part of the Products and will not be liable to the Customer for any loss or damage arising from any such delay. Any special delivery instructions must be received by the Company in a timely manner to enable the Company to comply with such instructions. Any failure by the Company to comply by reason of non-receipt of special delivery instructions will not entitle the Customer to repudiate the contract. It is the Customers responsibility to ensure that the Products conform to their requirements. The Company reserves the right to deliver the Products in whole or by instalments, as well as to deliver prior to the date for delivery and in such event the Customer must not refuse to take delivery of the Products.
